MEDICAL WAIVER

All parents/guardians KNOWINGLY AND FREELY ASSUMED ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for their child's participation.

All such forms will also RELEASE AND HOLD HARMLESS the River Falls School District, River Falls Dance Team, their coaches, their officers, officials/judges, agents, employees, volunteers, event participants, vendors, sponsoring agencies, sponsors, advertisers, and if applicable owners and leasers of premises used to conduct the Invite, with respect to any and all INJURY, DISABILITY, DEATH, and loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE REALEASEES OR OTHERWISE. During the athletes' stay at the event site, all athletes will be closely supervised in every activity by their coach. It is to be understood that the River Falls Dance Invitational, River Falls Dance Team and River Falls School District cannot be held responsibility for any unforeseen incident that might occur on the way to and from event.

All parents/guardians understand and authorize any representative of the River Falls Dance Invitational to locate qualified and licensed medical personnel and/or transport their athlete to an appropriate medical facility in the event that it may become necessary.

Both coach and Athletic Director have carefully read all the above statements, and with full understanding of the terms, consents to participation in the River Falls Dance Invitational.

Furthermore, the River Falls Dance Invitational, River Falls Dance Team and River Falls School District cannot be held responsible for any act, error, or omission on the part of any program participant or participants.

Additional expenses if incurred under any of these circumstances must be borne by the program participants. It is understood that the River Falls Dance Invitational has a NO REFUND policy. It is understood that the River Falls Dance Invitational, River Falls Dance Team and River Falls School District cannot be held responsible for any discipline problem encountered with an athlete. Any athlete possessing or using drugs or alcohol or behaving in any manner inconsistent with River Falls School District standards or local, state, or federal statutes will be immediately dismissed from the event. The parents/guardians and organization will be notified. The River Falls Dance Invitational, River Falls Dance Team and River Falls School District will not be held responsible for loss or damage to an athlete's personal belongings.

I have informed my athletes' parents/guardians that we have live videographers/photographers on site the day of the competition. The videos and photographs taken may be used within the River Falls Dance Invitational's promotional video and/or posted on the River Falls Dance Team's social media accounts, unless otherwise notified prior to the date of the competition.

CLASSROOM AGREEMENT

I understand that we may be allowed to use a classroom or designated area to store uniforms and equipment at River Falls Middle School. I also understand that these areas and their contents are property of the River Falls School District, and I understand that if anything in our area is broken and/or stolen, our school or organization will be responsible for replacing and/or repairing it, whichever is deemed appropriate by the River Falls School District.

- Do not open any desks, cabinets, etc. or use any of the computers, phones, or technological devices. If you need to use a phone, please see an invite official.
- Do not write on the blackboards, dry erase boards, or Promethean/Smart boards. Writing on a Promethean/Smart board will damage the item.
- Do not touch ANY classroom equipment.
- If you need to move desks/tables, please make sure they are returned to their original position before you leave.
- All trash should be placed in the trashcan before leaving the room. If you have a spill (water, make up, etc.) you can obtain paper towels from the restroom to clean up.
- Remember that although the hallways are monitored, the rooms are unlocked. Please secure your valuables accordingly. We are not responsible for any lost/stolen items.
- If you notice any damage when you arrive at your room or believe someone other than your team has caused damage, please report it to an invite official immediately.
- No loose glitter in classrooms (even with glue). This should be applied in bathrooms or locker rooms only.
- No food or drink (other than water) allowed in classrooms. Please eat in the cafeteria/concessions area.
